He learned thru this process that there is no Clerk of the Court at Justice Courts. We mentioned that the administrative assistant were unwilling to work with the couriers when they have a problem in some courts. The Judge's suggested we talk to the court managers. Patty & I also attended the Court Managers meeting and were able to speak to them. We were then given a list of each of the court manager's names and phone numbers. We were not to distribute them to all process servers just amongst the board. Bill suggested we put in some information in the newsletter of the meeting and send the court manager's a copy. He also stated that per statute he has learned thru all this process that a Writ needs to be signed by a Judge. We were to add bill as a contact person in the newsletter for the membership to bring situations or problems to him.

#### LEGISLATIVE REPORT:

John Moody stated nothing moving quickly. The House & Senate are all worried about the budget. Trespass & Assault bill possibly being re looked at. Have him
